

WWE HARDEE'S SWEEPSTAKES
OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM THE PRIZE. A PURCHASE OR
PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

The WWE Hardee's Sweepstakes ("Sweepstakes") is sponsored by World Wrestling Entertainment, Inc. ("Sponsor"), 1241 E. Main St., Stamford, CT 06902 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on November 15, 2019 at 12:00 PM Eastern Time ("ET") and ends on December 6, 2019 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of the forty-eight (48) contiguous United States and the District of Columbia (excluding Alaska and Hawaii) who are at least twenty-one (21) years old at the time of entry. Employees of Sponsor, Administrator, CKE Restaurants Holdings Inc., and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void in Alaska, Hawaii, and where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

- 3. HOW TO ENTER THE SWEEPSTAKES:** There are three (3) ways to enter the Sweepstakes:
 - A. Online:** During the Sweepstakes Period, an eligible entrant may visit www.wwehardeessweepstakes.com ("Website") and complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, and zip code. Upon the successful submission of the registration information, an entrant will receive one (1) entry into the Sweepstakes.
 - B. Instagram:**
 - i. Sign into his/her Instagram account (entrant may create an Instagram account for free if he/she does not already have one);
 - ii. Become a follower of @Hardees and @WWE on Instagram (if not already following @Hardees and @WWE). There is no charge to sign up for Instagram or to follow either @Hardees and @WWE; and
 - iii. Compose a new Instagram post that includes the hashtag "#WWEHardeesSweepstakes" and tags @Hardees and @WWE to receive one (1) entry into the Sweepstakes.

C. Twitter:

- i. Sign into his/her Twitter account (entrant may create a Twitter account for free if he/she does not already have one);
- ii. Become a follower of @Hardees and @WWE on Twitter (if not already following @Hardees and @WWE). There is no charge to sign up for Twitter or to follow @Hardees and @WWE; and
- iii. Compose a new Tweet that includes the hashtag “#WWEHardeesSweepstakes” and tags @Hardees and @WWE to receive one (1) entry into the Sweepstakes.

The content included in the entry will not be judged or used in any way to determine the winner. By entering the Sweepstakes and using the hashtag “#WWEHardeesSweepstakes”, entrant hereby agrees to be bound by these Official Rules. Instagram and Twitter entries will be deemed made by the authorized account holder of the Twitter or Instagram account the entry is submitted from at the time of entry. The “authorized account holder” is the person who is assigned to the Twitter account or Instagram by the online service provider. An Instagram or Twitter entrant must have a non-private Twitter account or Instagram account to enter the Sweepstakes and must be a follower of @Hardees and @WWE on the platform used to enter until January 6, 2020 for potential winner notification purposes to be eligible to win/claim the prize. If an entrant does not have a non-private Twitter account, he/she can create one at no cost by visiting www.twitter.com. Due to the way Instagram operate its services, entries from users with protected or private accounts (i.e., entrant has set his/her account so that only people the entrant has approved can view his or her updates) may not be received. If an entrant enters from his/her wireless phone, the entrant’s wireless service provider may charge the entrant. Entrants should consult their wireless-service providers regarding their pricing plans. Message and data rates may apply. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Twitter or Instagram.

Twitter and Instagram Entry Requirements: You are not required to provide any content (including, text, photos or videos) other than the designated hashtag (#WWEHardeesSweepstakes) and the designated tags (@WWE and @Hardees) in connection with Twitter and Instagram entries. Posting any additional content will not increase your chances of winning. If you choose to post any additional content, any content you submit as part of your entry via Twitter or Instagram must comply with the submission guidelines immediately below (the “Submission Guidelines”). Any entrant that in Sponsor’s sole and absolute discretion, violates these Official Rules or the Submission Guidelines below will be disqualified and/or will not be eligible to win a prize.

- Entry must be an original work;
- Entry must be in English (except for commonly understood foreign words);
- Entry must comply with Twitter terms of use located at <https://twitter.com/tos/> and/or Instagram terms of use located at: <http://instagram.com/about/legal/terms/>;
- Entry cannot have been published previously by any party other than the entrant;
- Entry must be suitable for publication (i.e., may not be obscene or indecent);

- Entry cannot contain trademarks, logos or trade dress owned by any third party, or advertise or promote any brand or product of any kind, other than the Sponsor's or Hardee's;
- Entry cannot contain copyrighted materials owned by others (including photographs, sculptures, paintings and other works of art or images);
- Entry cannot include the name, likeness, photograph, or other indicia identifying any person, living or dead, without written permission from that person;
- Entry cannot be sexually explicit or suggestive, violent or derogatory of any ethnic, racial, gender, religious, professional or age group or otherwise derogatory;
- Entry cannot promote alcohol abuse, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing), any activities that may appear unsafe or dangerous, or any particular political agenda or message;
- Entry cannot describe or depict any illegal activity or violation of any state or federal law;
- Entry must not include any personally identifiable information (full name, e-mail address, telephone number, etc.);

If any Entry fails to comply with any of these Entry Requirements or any other provisions of these Official Rules, at the Sponsor's sole discretion, Sponsor reserves the right to disqualify the entrant.

By participating in the Sweepstakes, entrant understands that he or she is providing his or her information to Sponsor and not Twitter, Inc. ("Twitter") or Instagram, Inc. ("Instagram"). Further, entrant specifically agrees to release Twitter and Instagram from any and all liability associated with this Sweepstakes. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Twitter, Instagram, or any of their affiliates.

Entry Limit: There is a limit of one (1) entry per method of entry per person per day (for a total of three [3] entries per day). If more than one (1) entry per method of entry per day is received from the same person, telephone number and/or e-mail address the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor's sole discretion, may not be eligible to win the prize. 4. RANDOM DRAWING: On or around December 9, the Administrator will randomly select one (1) potential winner from all eligible entries received. The winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZE, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

A. Prize (1): The prize is a trip to WWE's Big Southwest Event in Houston, Texas ("Prize"). Trip includes round-trip coach class air transportation from a major commercial airport near winner's residence to Houston, Texas for winner and one (1) adult guest (age twenty-one [21] or older), two (2) nights hotel standard accommodations (single room/double occupancy), ground transportation to and from airport and hotel, and two (2) tickets to a WWE Big Southwest Event to be held on January 26, 2020. Winner must travel on January 25, 2020 and return on January 27, 2020 or Prize will be forfeited. Winner and guest must travel on the same itinerary. The actual value of the trip may vary depending on point of departure and fluctuations in the cost of air transportation. Any difference between the estimated ARV and the actual value of the Prize will not be awarded. If winner resides within a 150-mile radius of destination, ground transportation may be provided in lieu of air transportation, and no compensation will be provided for any difference in Prize value. Travel dates are subject to availability; blackout dates and other restrictions may apply. Sponsor bears no responsibility if any event, element or detail of the Prize is canceled, postponed or becomes unavailable for any reason. Should any event, element or detail of the Prize become unavailable, the Sponsor shall have no obligation to the winner aside from providing the remaining portion of the Prize, minus any unavailable event, element or detail. Winner may attend the event with a guest who is under the age of majority if: (a) the parent or legal guardian of the guest has executed an Authorization Form, giving consent, a Liability Release and, where legal, a Publicity Release, on such guest's behalf and will accompany the minor guest to the Event; and (b) Sponsor, in its sole discretion, has granted its approval. In all cases, the Winner's guest, or the parent/legal guardian of any guest who is a minor in his or her state of residence, will be required to sign a Liability and Publicity Release (except where prohibited by law). No more than one (1) Prize will be available in the Sweepstakes. The ARV of the Prize is \$2,500.

B. Odds of Winning: The odds of winning the Prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period.

C. General Conditions: In no event will more than one (1) Prize, be awarded. If, for any

reason, more Prize notifications are sent (or more claims are received) than the number of Prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of Prizes through a random drawing from among all eligible Prize claims received.

- 6. HOW TO CLAIM THE PRIZE:** The potential winner is subject to verification of eligibility and compliance with these Official Rules. After the random drawing, Administrator will notify the potential winner via e-mail at the e-mail address provided at the time of registration or on either Twitter or Instagram by a Direct Message from @WWE (depending on his/her method of entry) with instructions on how to claim the Prize. The potential winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within three (3) calendar days from the date of attempted notification or the Prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Failure to provide all required information and a signature on the documents within the stated time period may result in forfeiture of the winner's right to claim the Prize, and may result in the Prize being awarded to an alternate winner, if time permits. If the potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept the Prize, the respective Prize may be forfeited. If the Prize is forfeited, the Prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible entries, as determined by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver the Prize, the Prize may not be re-awarded. Upon verification of eligibility, the winner will be contacted to make arrangements for the trip. Any portion of the Prize not accepted by winner will be forfeited. The winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for the Prize won. Sponsor will issue an IRS Form 1099-MISC for the winner. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. The Prize will only be awarded to a verified Winner.

Sponsor will attempt to notify the potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including, without limitation, e-mails that are not received because of the winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. Prize is non-transferable and no Prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute the Prize of equal or greater value in case of unavailability of the Prize or force majeure, at Sponsor's sole and absolute discretion. Sweepstakes Entities shall not be held responsible for any delays in awarding the Prize for any reason.

THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN CONNECTICUT. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN FAIRFIELD COUNTY, CONNECTICUT. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT**

OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
